### RE: Arrests made in Sacred Heart Church Burglary

Sheriff David Gould reports that the Cayuga County Sheriff's Office has arrested two persons in connection with the burglary at Sacred Heart Church on Melrose Rd. in the Town of Owasco, which occurred back on August 31<sup>st</sup> 2011. A tip from a citizen lead Detectives to conduct several new interviews which resulted in the two arrests.

Charged are:



**Daniel A. Edersheim, age 20, of 54 Adams Ave. Auburn, N.Y.**

- Burglary in the third degree-felony
- Petit Larceny-misdemeanor



**David Z. Calkins, age 21, of 82 Havens Ave. Auburn, N.Y.**

- Burglary in the third degree-felony
- Criminal Possession of Stolen Property in the fourth degree-felony

Edersheim was arrested at the Cayuga County PSB on 11/09/11, arraigned in the Town of Owasco Court and remanded to the Cayuga County Jail in lieu of \$2500 cash or \$5000 bond.

Calkins was arrested this morning at the Cayuga County PSB, arraigned in the Town of Owasco Court and remanded to the Cayuga County Jail in lieu of \$2500 cash or \$5000 bond.

Two gold ciboria have been recovered. One has been severely damaged and the other appears to be undamaged. Both were recovered in the possession of Calkins.
